- i. Human rights of all migrants, social inclusion, cohesion and all forms of discrimination, including racism, xenophobia and intolerance (April/May 2017);
- ii. Irregular migration and regular pathways, including decent work, labor mobility, recognition of skills and qualifications and other relevant measures (October 2017);
- iii. International cooperation and governance of migration in all its dimensions, including at borders, on transit, entry, return, readmission, integration and reintegration (June 2017);
- iv. Contributions of mi grants and diasporas to all dimensions of sustainable development, including remittances and portability of earned benefits (Jul y 2017);
- v. Addressing drivers of migration, including adverse effects of cli mate change, natural disasters and human -made crises, through protection and assistance, sustainable development, poverty eradication, conflict prevention and resolution (May 2017);
- vi. Smuggling of migrants, trafficking in persons and contemporary forms of slavery, including appropriate identification, protection and assistance to migrants and trafficking victims (September 2017).
