Introduction

This document has been prepared by the TS in response to a request from the Member Countries of the RCM, which was agreed in the framework of the Meeting of the Regional Conference on Migration to generate guidelines for a regional position towards the Global Compact for a safe, orderly and regular migration, held on March 29th in Washington, DC, United States.

The following document consists of a compilation of agreements and decisions (hereinafter referred to as "statements") resulting from the conclusions and political declarations resulting from the RCM Vice-Ministerial meetings, which have been approved in the framework of the Regional Conference on Migration between 1996 and 2016.

In order to facilitate the consultation and search of particular statements, this document categorizes, firstly, by theme the compiled statements. The themes defined in order to undertake this first categorization are the same as those defined by the United Nations for the thematic consultations established in the document "Modalities for the intergovernmental negotiations of the global compact for safe, orderly and regular migration".

As it will be recalled, the modalities document states that during the first phase of the negotiation process of the Global Compact for regular, orderly and secure migration, the following thematic consultations will be held:

- I. Human rights of all migrants, social inclusion, cohesion and all forms of discrimination, including racism, xenophobia and intolerance (April/May 2017);¹
- II. Addressing drivers of migration, including adverse effects of climate change, natural disasters and human-made crises, through protection and assistance, sustainable development, poverty eradication, conflict prevention and resolution (May 2017);
- III. International cooperation and governance of migration in all its dimensions, including at borders, on transit, entry, return, readmission, integration and reintegration (June 2017);

- IV. Contributions of migrants and diasporas to all dimensions of sustainable development, including remittances and portability of earned benefits (July 2017);
- V. Smuggling of migrants, trafficking in persons and contemporary forms of slavery, including appropriate identification, protection and assistance to migrants and trafficking victims (September 2017)
- VI. Irregular migration and regular pathways, including decent work, labour mobility, recognition of skills and qualifications and other relevant measures (October 2017);

In those cases in which a given statement, because of its scope or content, is relevant for several thematic sessions, a specific note in this regard has been made at the end of the statement. In these cases, the statement has been included in all the different sections of the document for which the statement is relevant.

Because the topics of the thematic consultations are relatively broad, the TS has defined sub-themes in order to facilitate the search of particular statements on specific topics. These sub-themes have been defined subjectively by the TS as a proposal to divide the major themes defined by the United Nations for the thematic sessions. These do not correspond to any official guidelines.

With the same objective of facilitating the search of statements on specific topics, this document is organized according to a third criterion of categorization. This consists in dividing statements into three categories: principles, understandings and commitments. These categories are the same as those set out in the New York Declaration when it identifies the type of products that the Global Compact should deliver. In order to carry out this categorization the following color codes have been used:

Again, this categorization has been made intuitively by the TS, since there is no official definition or parameter that establishes a definition for what is understood by principle, understanding or commitment. To perform this categorization, the TS has used, the following definitions to understand these concepts:

Principle - Norm or fundamental idea that governs thought or behavior.

Understanding - intelligence or sense that is given to what is said or written.

Commitment - agreed obligation.

For each one of the statements included in this document, a reference to the RCM meeting in which a the statement has been approved has been included.

Finally, a column has been included in order to obtain the opinion of the Member Countries regarding whether a statement is still valid or not. This has been done with the intention of facilitating the gathering of preliminary inputs from Member Countries for the elaboration of RCM inputs for the construction of the Global Compact.
